All the brothers received a WWII proclamation from President Bush, and Henry also received birthday greetings from the President and his congresswoman Linda Sanchez. The Long Beach Press-Telegram newspaper was on hand for photos, and ran a story about the party. Sadly, none of the brothers ever heard a word from Governor Arnold Schwartzenegger's office, whom we also notified.

Dear Ms. Susie Pidsosny,

*First, before I turn to my request, please let me introduce myself:* 

My name is Mike Smeets. I am a 36-year-old historical researcher from Landgraaf, The Netherlands. I am married and have a little son of 5 years old.

For many, many years now I have been studying the exploits of the German Battlegroup Peiper and its US adversaries during the Battle of the Bulge 1944. Over the years, I have been able to contact several German and US veterans who helped me reconstruct the events as they happened so many years ago. I am also in contact with several well known authors such as Michael Reynolds and Danny S. Parker, who display their vast knowledge in this field everytime I need their assistance. As I am living very near to the beautiful Ardennes, I have visited the actual battlefields numerous times already.

Now turning to my request: during the Bulge your proud unit – 612th TD located at the little Belgian village of Honsfeld – was overrun by the German offensive on December 17th 1944.

Some men however put up resistance and this caused the German SS and Paratroopers severe losses however, US losses in men and material were higher. In addition, some German SS-men were also responsible for murdering members of your unit in cold blood after the fighting was over.

Dear Ms. Pidsosny, would it be possible to receive your Association's help regarding information about these brutal killings that occurred on this fateful day in December 1944? In addition, would some of the 612<sup>th</sup> veterans be willing to share their experiences with me about what happened to them, now 62 years ago? (Last week I already wrote a letter to Mr. Fayne Haynes - Association Chairman 612th TD Association.) It would be a great honor and privilege if you would answer my request and receive the help of some of the men who were actually there!

Thank you very much in advance and wishing you and yours all the best from Landgraaf/The Netherlands

Dear Susie Pidsosny,

I am a writer working for twelve years on a history of Battle Group Peiper in the Battle of the Bulge. In 1995-1996, courtesy of Jack Flanagan, I have corresponded and interviewed many members of the 612th TD Battalion who are no longer living: Devers Bryant, Ralph LeBlanc, Francis Hayes, George Block and others.

I also interviewed Elmer Haynes and W.T. Hawkins, who I understand are still with us. In the last few weeks, I have been finally writing the story of Honsfeld and want to get it right. From what I understand, there may have been THREE separate groups in three houses who attempted to surrender under a white flag and were fired upon: One under Lt. Grandy, another under Lt. Baysek and still another under Lt. Chandler. However, I want to make sure that I have this correct.

It would also be useful to know who of the many members of 612th TD Battalion mentioned in my write up, were in the same gun crews or in the same building with the men listed above. Is there a member roster for Company B for the Battalion in December 1944?

There is one other very important question: I understand that T/5 Michael Kardos, listed as missing in action for sixty years, was found to have died in Stadkyll, Germany on 29 December 1944. It is very important that I find out more about this episode so that I might get this correct in my book. Do we know how Mr. Kardos died or anything else about his death?

My book, \_At the Crossroads: Joachim Peiper and the Malmedy Massacre - will be published in 2008 by DaCapo Press. This has taken me a very long time, but I hope I am not too late to get the story told properly.

I very much appreciate any and all assistance.

Following is the web article.

S.S. colonel Jochen Peiper was one of the most controversial figures of the Second World War. Handsome, intelligent, and impetuous, he volunteered for the Waffen S.S. at an early age and dedicated his life to the Nazi cause. Peiper was Heinrich Himmler's ever-present personal adjutant in the early years of the war, and once on the fighting from with the Leibstandarte Adolf Hitler, he became known for a flamboyant and brutal style of warfare.

After the war, Peiper became the central subject in the bitterly disputed Malmédy war crimes trial, where he was condemned to death but ultimately released due to the efforts of Senator Joseph McCarthy and an Atlanta attorney Willis M. Everett, Jr. After moving to eastern France in 1972, he was harassed by the French Communists and died in a gun battle at his home on July 14, 1976–Bastille Day. His assassins were never identified.

In A Deadly Past, historian Danny Parker highlights the fascinating characters and personalities of Peiper's story and asks such questions as how an intelligent, cultured, and capable man could decide to embrace malevolence? Through rich narrative and extensive interviews with German veterans, Belgian, Italian and French civilians, and participants in the trial at Malmédy, A Deadly Past helps us to fathom the world of Hitler's Third Reich, a morally inverted world in which cruelty was good and kindness belied fatal weakness.

# **Operation America**

In our last newsletter I had printed information regarding Operation America. The following is a biographical release of the 612<sup>th</sup> Tank Destroyer Battalion's own **Rainer Griswold**. Special thanks to Warren Shanks McEachern for allowing this article to be re-printed in our newsletter.

Operation America Biographical Release #2 Rainer Griswold Private First Class, U.S. Army # 34 586 265 World War 2

Cerisy Forest, in France, is a long way from the small Coffee County farm where Rainer Griswold was born in Tennille, Alabama.

Yet it was here, that PFC. Griswold along with the rest of his unit the 612th Tank Destroyer Battalion first met the German Army in battle. Rainer's journey to combat began on December 18, 1942, when he was inducted into the Army at Fort McClellan, Alabama. Assigned to the Field Artillery, and given serial number 34 586 265, he received intensive training as a Light Machine Gunner. As a member of a machine gun crew, he was responsible for the cleaning, care and accurate firing of his weapon. His training included making estimates on distances to targets as well as the use of terrain for concealment. He was indoctrinated in the realities of war through the use of "live" fire exercises which taught him to estimate elevation, and how to provide covering fire for cannons.

Like most of his generation, Rainer Griswold found military service an experience completely alien to his civilian life. From 1936 to 1942, he assisted his father in the operation of their 500acre Coffee County farm. He helped cultivate cotton, peanuts, and vegetables. Married to the former Norma Dismukes his childhood sweetheart, Rainer was a typical young Alabama farmer separated from the farm and family he loved by a world gone mad with war. His separation from Norma was a blow that weighed heavy on his heart. Together, they endured the horror of the Second World War, together, and apart from, each other. Whilst Rainer was away in Europe, both his wife, and family, worked to produce much needed vegetables and livestock for the war effort. A lively correspondence was maintained via the Army's V-mail program by the two "love birds."

The Cerisy engagement was followed by intense combat at the famous Normandy breakout at Vire. Supporting allied armies in the capture of Brest, Griswold's battalion was diverted to Belgium to support operations against the infamous Siegfreid line. This put the 612th Tank Destroyer Battalion in a strategic position to foil German intentions during the Battle of the Bulge. At the Bulge, it was so cold, the 612th's 3 inch cannons froze to the ground creating a line the Germans would never pass. The fighting was so fierce, and the contribution of the 612th so significant, select companies were awarded the Presidential Unit Citation and the Outstanding Unit Citation. The King of Belgium bestowed upon the Battalion the coveted Kingdom of Belgium Fouragere. On December 29, 1944, the 612th Tank Destroyer Battalion was equipped with the new self propelled M-18 tank destroyers. This allowed the Battalion to join in the historic attack in the Monschau Forest bringing the Allies within sight of Germany. Crossing the Rhine River with his unit, PFC.

Griswold participated in the dash through central Germany which terminated in the city of Leipzig on May 8, 1945. Ending his arduous combat service in World War 2, with occupation duty, Rainer Griswold returned to the United States on November 29, 1945.

Rainer Griswold was one of a very few soldiers to participate in five major campaigns following the invasion of Normandy. These were recognized by a silver service star to his European Theater service medal. Records of the U.S. Army list him as participating in the following events.

- 1. Normandy Campaign (War Department General Orders #33)
- 2. Northern France Campaign (War Department General Orders #46)
- 3. Ardennes Campaign (War Department General Orders #40)
- 4. Rhineland Campaign (War Department General Orders #40)
- 5. Central Europe Campaign (War Department General Orders #46)

On December 5, 1945, Rainer Griswold was Honorably Discharged from the U.S. Army at Fort McPherson, Georgia. For his service he received the following awards:

- 1. Army Good Conduct Medal
- 2. European African Middle Eastern Service Medal with 1 silver star
- 3. American Campaign Medal

Rainer Griswold returned to his Coffee County farm and family. Here he received a personal commendation from President Harry S. Truman. "To you who answered the call of your country, and served in its Armed Forces to bring about the total defeat of the enemy, I extend the heartfelt thanks of a grateful Nation. As one of

the Nation's finest, you undertook the most severe task one can be called upon to perform. Because you demonstrated the fortitude, resourcefulness, and calm judgment, necessary to carry out that task, we now look to you for leadership, and example in further exalting our country in peace." At home he farmed on shares for his father until his death on June 20, 1970. He is buried alongside his beloved Norma in New Hope Cemetery, scant yards from his rural farm. The final tribute to Rainer came from the President of the United States, "The United States of America honors the memory of Rainer Griswold. This recognition is presented on behalf of a grateful nation in recognition of devoted and selfless consecration to the service of our country in the Armed Forces of the United States." It is said that he lost his smile following his return from the war, and Norma's untimely death, on January 8, 1961. Whatever the explanation for this is, its answer might be found in the line of cannons that was never crossed at the Battle of the Bulge.
