After a lovely lunch some folks headed back to the hotel while others headed out to do some shopping and a few others went back to the **Haynes Museum** to make some purchases.

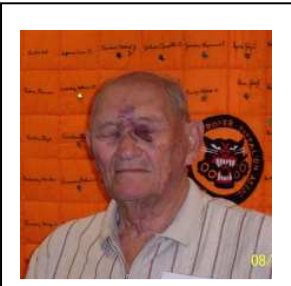

WORLD WAR II VETERAN SAYS INSCRIBING GI'S NAMES ONLINE SERVES AS A LASTING MEMORIAL

NASHUA — Considering the amount of love and adoration that Red Sox legend Ted



Dick Mohrmann's mission is to raise awareness of the currently underutilized World War II online registry.

Williams generated during his baseball career and retirement years, it's no surprise that Joe Arseno, the person responsible for listing Williams' name in the official World

War II online registry (www.wwiimemorial.com), describes himself as a baseball fan.

What is surprising, however, is that neither Arseno, nor any member of Red Sox nation, nor Ted Williams' own family members, has sprung for the \$10 fee to post a photo of Ted in his military uniform on that same official WW II memorial Web page. "This omission is more evidence of just how underused and underappreciated the WWII online registry continues to be, three years after it was established, according to World War II veteran Dick Mohrmann of Nashua.

"The World War II Memorial (located in Washington) has an electronic registry where all WW II veterans and civilians who contributed to the war effort can have --- their names and military units recorded for future generations to look up their family

members," Mohrmann explained.

With Veterans Day approaching, Mohrmann thinks it's an appropriate time to

make more people aware of the registry's existence

"I have found that there are many veterans who do not have their names registered," Mohrmann said. "I believe that many of them are not aware that they can put their name in free of charge, either by mail or online."



World War II Memorial in Washington opened to the public on April 29, 2004. To complement the physical monument, an electronic memorial is now available online.

Family members can put a deceased veteran's name into the online registry also, Mohrmann pointed out. They can also add a photo of the veteran for \$10. Mohrmann is a U.S. Army veteran of World War II, having fought in the Philippines as a member of the 33rd Infantry Division, 136th Regiment, Company E. He also took part in the postwar occupation of Japan.

"I have a little address book that's 60 years old with addresses of the buddies who were with me in the service back then," added Mohrmann, who grew up in Beachlake, Penn. "I tried to look up as many of them as I could online and I couldn't find any of them in the online registry. I just thought what a shame that they're not in there because all their relatives in the future could look up a part of their family history that way, too."

Mohrmann said he has spent many fascinating hours searching the WW II memorial online database and has discovered some interesting names and faces there. He demonstrated for the *Broadcaster* last week that the site is searchable by a veteran's hometown or

last name. By typing the name "Aurness" in the last name box, Mohrmann brought up individual web pages honoring some of the more famous veterans of WWII.

These include TV and movie actors James Aurness — who later dropped the "U" from his last name as the actor of Gunsmoke fame and Clark Gable. There is also a page honoring actress Carole Lombard Gable, Clark's wife, who died on Jan. 16, 1942 while returning home from selling war bonds overseas. Lombard was considered to be the first woman known to have been killed while serving her country during World War II, according to Betty Samson Andrews, Lombard's cousin, who paid the extra \$10 to post Lombard's photo on the registry site.

"But the site is not just for people who were killed in action," Mohrmann explained. "It's for any veteran that was in World War II, or any civilian who contributed to the war effort. Their name can be put in there. Too many of them are not (online) right now, and for the future I think it's worthwhile."


To register a WWII veteran or civilian war effort honoree, go to www.wwiimemorial.com; then click on "Registry"; then click on "Register an honoree."

Thanks to **Mary Ann Wesoly** for forwarding the WWII Registry article. If any of our members or their families need help with registering one of our veterans on the WWII site

Generally, the information needed is the veterans full name, hometown and the name of the person honoring the veteran.

Here is a copy of my father **Willard Webb's** registry just to give you an idea of what it looks like and the information you need to provide.

Since receiving this e-mail from **Dick Gaut** he has been in touch with **Dianne ‘Sara’ Kelton** whose father **Avery Sanders** served with **Dick**.

Dear Sara,

I enjoyed your e-mail, and appreciate your telephone call this morning. It was a real joy hearing from you, and about my battalion group.

I did find a photo that included your Dad and our gun crew. I will have copies made for you and for your Dad and send them on to you. I may be able to find more that included him, and will keep looking.

And, I do enjoy very much doing research on the internet. There is a world of information out there that I have enjoyed studying and doing research on it. I am into prospecting, geology and mineral study. I did this to some degree in the fox holes of France. (Ha! Ha!) By the way, on my e-mails, since I am slow at typing, my wife, Janet does the typing as I dictate to her. She is a "young" girl, just was 27 -- no, that was 72. I made a mistake there. We have been married for 34 years now.

About your Dad's hearing problem -- I share that problem. I fought with the V.A. for many years about my service-related hearing loss due to the high exposure to gunfire and explosions. I tried getting help from the VFW, but it didn't get far. I went to the D.A.V. -- and with the D.A.V.'s help, I finally received a portion of service-related disability. I did, in fact, tell the doctor at my discharge about my hearing loss, and that was a help to me. Still, as one male nurse told me at the V.A. one day, with our MOS for our service, there is not any doubt at all as to what contributed to our hearing loss (our MOS was 610). I did get hearing aids from the V.A. that are supposed to be the best of current technology. The problem is that my (and your Dad's) hearing loss is high frequency, and the aids simply increase the volume, not the tone. I feel sure that if he wanted to try to get the best out there of hearing aids he can at least get those from the V.A. So, your Dad should go to the D.A.V. and I feel sure that they will be glad to help him. You can advise the other people that come to the reunion to do the same thing. As old as we are, the V.A. starts paying us really good checks every month. So, please let all of the attendees to the reunion know about this, even though they have been turned down many times by the V.A. Possibly Susie can add this information to her newsletter, for any of the group that it would help. We can all use a few hundred extra dollars a month, even at this late date.

Hope you all had a wonderful reunion. I send my best wishes and my prayers for everyone there. Be sure to keep in touch.

Susie then wrote to Mr. Gaut asking for more information regarding obtaining disability claims for our veterans. Here is his reply:

Dear Susie,

Thank you again for your interest in all of us 612'ers. I'm glad you had at least 8 of us still around to enjoy being together.

*About the disability for hearing loss for those of us who were exposed to extensive gun fire and explosions: I had gone to the V.A. years ago, but had no success. I then went to CIGNA, my health care provider at the time, and had an independent hearing test made. It showed my hearing loss was extreme in high frequency areas. I then went back to the V.F.W. with that information and tried again to get a V.A. hearing test. They tested my hearing and said they found nothing wrong with it. At the time I was discharged in 1945, I called my hearing problem loss to the examiner and it was recorded on my medical record. But, the examiner said it was nothing to worry about. I was like so many others and just glad to be alive and getting home. All the way through college and life, I had problems understanding certain tone ranges, and this became progressively worse. I went again to the V.F.W., but it did not put out enough effort to be of help to me. I then went to the D.A.V., **and with its efforts, I got another and very extensive hearing test by the V.A. that did prove my hearing loss was substantial.** My army service records were backed up my MOS 610 (which is everyone in the 612 TD Btn). **In recent years, the military services have acknowledged that hearing loss of combat veterans is the primary cause for severe hearing loss.** The D.A.V. had appealed the decision about my hearing loss being service-related. In 2002, the V.A. finally said that the "preponderance" of the evidence supported my contention that my hearing loss was caused by my service. I then started receiving disability compensation for that hearing loss sometime in 2002 -- late, but welcome. The "preponderance" of the evidence will support ANY WWII veteran*

who was exposed to such combat conditions as we all were.

Please tell everyone to go straight to the D.A.V. -- bypass the American Legion and the V.F.W. The D.A.V. is a dedicated group for helping ALL veterans. The D.A.V. did not accept defeat from the V.A. ruling on my hearing loss, and continued its efforts to get me compensation, which is a good amount and certainly worth going after. There was no cost to me whatsoever, and I never had to resort to an attorney to represent me. The D.A.V. did that for me. No matter how long we have to live from here on or how old we are, whether it is 6 months or 6 years, we are all entitled to this long-deserved benefit. The amounts paid runs up into the hundreds of dollars per month, depending on each individual circumstance and the severity of the hearing loss.

My best wishes to everyone. You are a special person to be continuing to help all of us keep in touch with each other.

Iris Morris' Butter Pecan Cake

1 box butter pecan cake mix	1 Cup waer
1 can coconut pecan icing	4 eggs
¾ Cup vegetable oil	1 Cup chopped pecans

Sprinkle ½ Cup of pecans in bottom of Bundt pan that has been sprayed with cooking spray.

Mix all remaining ingredients together and pour into pan.

Bake at 350 for 50 to 60 minutes.

Dennis Riley's Special Sugar Cookies

1 Cup powdered sugar	1 tsp. vanilla extract
1 Cup granulated sugar	1 tsp salt
1 Cup butter	1 tsp baking soda
1 Cup oil	1 tsp cream of tartar
2 eggs	

4 Cups plus 4 heaping Tablespoons flour

Cream sugars, butter, oil, eggs and vanilla.

Add dry ingredients, mix well. Roll into small balls.

Flatten with bottom of a small juice glass that has been rubbed lightly with oil and dipped in sugar.

Bake at 350 for 10 minutes. Makes approximately 100 cookies.

Dennis Riley's Pecan Puffs

1 egg white, fluffed
1 Cup brown sugar
1 tsp Vanilla
2 Cups chopped pecans

Preheat oven to 450.

Fold sugar in to egg white. Add vanilla. Add pecans. Drop with teaspoon onto greased cookie sheet.

Place cookies in oven and turn over OFF. Leave in 10-12 minutes. Makes 40 cookies.

Hazel Scott's Marvelous Pound Cake

1 pkg. yellow cake mix	⅔ Cup vegetable oil
1 3 oz. box orange Jello	1 Tbl. Orange extract
1 Cup very hot water	1 or 1 ½ Cups Confectioners sugar
4 eggs, beaten	Enough orange juice to make glaze like you want it.

Dissolve the jello in the cup of hot water, stir until cool, set aside. Add the beaten eggs, oil and extract to the cake mix, blend well, add jello and beat until well mixed.

Bake in a Bundt pan at 350 for 40 or 50 minutes until firm and brown on top. Prick the top of the cake with a fork or tooth pick.

Mix confectioners sugar with juice and pour overcake. I like to cool the cake before adding the glaze.

(You can also use lemon jello, extract and lemon juice if you prefer lemon cake).
